# 1. CALL TO ORDER:

The MPO Citizen's Technical Advisory Committee Vice Chair, Stuart Gardner, presided and called the meeting to order at 7:02 p.m. Sandy Shackleford took attendance by roll call, and certified that a quorum was present and then read the Notice of Electronic Meeting and Commissioner and Public Protocol.

#### 2. MATTERS FROM THE PUBLIC: None.

#### 3. Approval of Draft Meeting Minutes (Minute 3:29):

**Motion/Action:** Lee Kondor made a motion to approve the minutes, Nicholas Garber seconded the motion and the motion passed unanimously.

#### 4. RIVANNA RIVER BICYCLE AND PEDESTRIAN CROSSING (MINUTE 4:32):

Sandy Shackelford reported on the Rivanna River Bike/Ped Crossing committee meetings to date. The next meeting is tomorrow, January 20. She discussed the Smart Scale project scoring and reminded the committee that the MPO will be developing a public workshop to discuss all the Smart Scale projects in the area.

Ms. Shackelford presented the three alignments being considered and explained that the Stakeholder Advisory Committee determined that the Riverside Avenue alignment could be eliminated due to impacts on the park and the neighborhood.

Ms. Shackelford continued by reporting that there are parking concerns at Riverview Park to be considered and mitigated. She also described the network connectivity considerations for the three options presented: Chesapeake Street, E. Market Street, and Broadway Street. There was a discussion about the pros and cons for each of the options, including the projected costs.

Ms. Shackelford asked the committee what type of feedback to look for from the public and the best format to get that input.

### **5. STAFF UPDATES (MINUTE 1:17:00):**

# **VDOT Project Pipeline**

Chuck Proctor reported that there are two projects in the MPO area – on at 22 and 250 in the Shadwell area, and the other in the Pantops area. VDOT is considering some Park and Ride lots, including the State Farm parking lot and another south of I-64. There will be an online survey that will go live online at the end of the month to get feedback from the public. He noted that most of the projects in the Pantops area are bike and pedestrian related, and a couple of intersection projects. Nicholas Garber said he would be interested in learning more about roundabouts.
