
2010 Base Percent of External Trips






2040 Existing and Committed (E+C) Base (No-Build)




2040 State Farm Blvd Connector Congestion




2040 State Farm Blvd Connector Select Link Analysis



2040 State Farm Blvd Connector Percent of External Trips










