6. STAFF UPDATES (MINUTE 59:08):

Rivanna River Bike/Ped Crossing

Sandy Shackelford reported that they finalized the appointments from each of the recommended groups for the stakeholder advisory committee for the Rivanna Bike/Ped bridge project. The first meeting will be on November 30. She is working on getting a website set up to include all of the information.

The other Smart Scale projects will be tackled in more depth in January. She will be working with VDOT on an outreach program for engagement with the community. She will also be working with localities with the Avon and 5th Street improvements and the multi-modal improvements. VDOT Project Pipeline (1:03:33)

Chuck Proctor wrapped up the second round of the stakeholder group meetings with Albemarle County and the residency on the projects in the area. VDOT has given them preliminary recommendations and are moving into in-depth alternative analysis and recommendations. 7. FUTURE DISCUSSION TOPICS (MINUTE 1:10:48):

Mr. Kondor mentioned that he reached out to Tim Padalino from Albemarle County and Chris Gensic with City Parks and Rec regarding the Rivanna Trails gap at Woolen Mills and Riverview Park. At some point, they said, they are considering approaching property owners to potentially grant right of way to extend the trail.

Mr. Fessel asked if there is anything being done to prevent the back up on 29 near Cane's Restaurant.

Mr. Proctor said there needs to be a connection in the rear of the properties so there is another option for entering and exiting the properties. That would be quite expensive, so he is not sure that would be a viable solution.
